OFFICIAL RULES

By entering the Promotion, entrants agree they are bound by and will comply with these Official Rules.

Promotion Period: Promotion starts at 12:01 a.m. (CET on December 2nd, 2021 and ends 6 p.m. (CET) on 28th February, 2022 (the “Promotion Period”). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible to win a prize. Sponsor’s or its designee’s computer is the official time-keeping device for the Sweepstakes.

Eligibility: Promotion open to legal residents of the 50 United States or District of Columbia states (excluding Puerto Rico) and Canada (excluding Quebec), as well as the countries in Europe (excluding Russia, Ukraine, Belorussia) and the Middle East (except Belgium, Hungary, Italy, Luxembourg, Poland, Portugal and any countries where this Promotion is forbidden or subject to local registration and/or other administrative requirements for validity), age 18, or the age of majority in their jurisdiction, whichever is older.
